## **INVITATION TO BID**

## HIRING OF GENERAL CONTRACTOR FOR THE CONSTRUCTION & FIT-OUT OF DBP OROQUIETA BRANCH (Infra BBG-WM 2019-001)

1. The Development Bank of the Philippines, Branch Banking Group – Western Mindanao (DBP, BBG-WM), through its Corporate Budget for 2019, intends to apply the sum of money below, inclusive of all applicable taxes, being the Approved Budget for the Contract (ABC) for the Hiring of General Contractor for the Construction and Fit-out of DBP Oroquieta Branch. - 2. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines. Prospective bidders must have completed, within the last ten (10) years, a contract similar to the Project (construction/renovation/fit-out of any commercial building in the Philippines) and whose value, adjusted to current prices using the National Statistics Office (NSO) consumer price indices, must be at least fifty percent (50%) of the ABC or P4,010,139.47.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
- 4. Interested bidders may obtain further information from the DBP, BBG-WM and inspect the Eligibility Documents at the BAC Secretariat beginning August 2, 2019. The schedule of activities is as follows:

The Invitation to Bid and Checklist of Eligibility Requirements may be downloaded from the DBP website (<a href="https://www.devbnkphl.com">https://www.devbnkphl.com</a>) and from the Philippine Government Electronic Procurement Service (<a href="www.philgeps.gov.ph">www.philgeps.gov.ph</a>). A complete set of the Bidding Documents may be purchased by interested bidders from the BAC Secretariat upon payment of a <a href="mailto:non-refundable-fee">non-refundable-fee</a> (mentioned above). Bidders are advised to regularly check the DBP and PhilGEPS websites for bid bulletins and other announcements regarding the project.
- 7. Bids shall be opened in the presence of the Bidders' representatives who choose to attend. Bids submitted after the deadline shall be marked only for purposes of recording the time of submission to the DBP BAC Secretariat but shall not be accepted, thus, they shall be returned to the bidder unopened and intact.
- 8. The DBP reserves the right to accept or reject any bid, annul the bidding process, reject all bids, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder/s. Furthermore, the DBP reserves the right to waive any minor defects and to accept the proposal most advantageous to the Bank.
