<p>Omnibus Statement</p> <ul style="list-style-type: none"> • Clause 10 – Advanced Payment <ul style="list-style-type: none"> ○ I believe it was mentioned that once we provide the Client ID's to DBP the service is deemed as "delivered". ○ To ensure that the above understanding is mutual between DBP and Refinitiv we would like to add a clause or statement that indicates: "for the avoidance of doubt, delivery of the service is made when Refinitiv first entitles the client IDs for the receipt of the information." ○ Can DBP release a Supplemental Bid Bulletin clarifying the point on Advance Payment and Delivery of ID's will be deemed as "delivered". 	<p>As explained during the Pre-bid Conference on 30 September 2021, after the receipt of ID's, it is no longer considered as advance payment.</p>
