Description

The Development Bank of the Philippines (DBP), through its Approved Annual Procurement Plan for FY 2021 intends to apply the sum stated below being the Approved Budget for the Contract (ABC), as payment for the Supply and Delivery of 4 units (Four-seater) Gang Chair at DBP Virac Branch through the Alternative Method of Procurement (Negotiated Procurement) - Small Value Procurement under Sec. 53.9 of RA 9184.

I. Approved Budget for the Contract

Two Hundred Forty Thousand Pesos (Php 240,000.00) inclusive of all applicable taxes.

II. Technical Specifications

Leatherette molded foam cushion upholstered backrest and seat; 1.4 mm thickness perforated metal seats sprayed with static powder after anti rust treatment; with armrest and steel frame legs.

Color : Black leatherette and matte silver for the steel base

Dimension : 2250 mm x 630 mm x 800 mm

Size Tolerance : ± 25.4 mm in either direction

Note : Design should be the same or similar as the attached photo

III. Condition of the Contract

1. The Supplier shall ensure that the items delivered are in accordance with the specifications required by DBP. DBP has the right to reject delivery if item/s delivered were found to be defective and not according to the required specifications/model.
2. The DBP may terminate/cancel the Purchase Order (PO)/Notice to Proceed (NTP) when the contractor fails to deliver, perform and comply with its obligation.
3. Delivery Period: The supplier shall complete the supply and delivery of the 4-seater Gang Chair within fourteen (14) calendar days after receipt of Purchase Order/Notice to Proceed.
4. Point of Delivery: DBP Virac Branch, Cong. Francisco Perfecto Building (Old Capitol Building), Rizal Avenue corner Eustaquio Street, Sta. Elena, Virac, Catanduanes.
5. Warranty: One (1) year warranty upon final acceptance of works by DBP.

IV. Payment

1. One-time, full payment shall be issued upon completion of all works.
2. When the supplier fails to satisfactorily deliver the goods under the contract within the specified delivery schedule, inclusive of duly granted time extensions, if any, the Supplier shall be liable for damages for the delay and shall pay DBP liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of delayed goods scheduled for delivery for every day of delay until such goods are finally delivered and accepted by DBP as stated in the Revised IRR Annex E of R.A. 9184
