



**Invitation to Bid for the Repair of Parking Area/ Tennis Court/ Basketball Court of
DBP Cebu Branch**

1. The Development Bank of the Philippines (DBP), through the Corporate Budget 2021 intends to apply the sum of **One Million Seven Hundred Fifteen Thousand Four Hundred Fourteen Pesos and 86/100 (Php 1,715,414.86)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Service of a General Contractor for the Repair of Parking Area/ Tennis Court/ Basketball Court of DBP Cebu Branch with **Project Identification No. RBAC-CV_BID_001-2021**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DBP now invites bids for the above Procurement Project. Completion of the Works is required **within Ninety (90) calendar days; reckoned from the date of winning bidder acceptance of the Notice to Proceed for the Repair of Parking Area/ Tennis Court/ Basketball Court of DBP Cebu Branch**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). A **"Similar Contract" shall mean construction of building/ renovation**.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Bidding is restricted to Filipino citizens/ sole proprietorships, cooperatives and partnerships, organizations, or corporations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from **DBP Cebu Branch and BBG-CEV, DBP Bldg. Osmena Blvd., P. del Rosario St., Cebu City** and inspect the Bidding Documents at the address given **starting November 16, 2021, Mondays to Fridays 10:00 AM to 2:00 PM**.
6. A complete set of Bidding Documents may be acquired by interested bidders **on November 16, 2021** from given address and website/s and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (Php 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fee via physical presentation of original Official Receipt (OR). Bidders shall also be given the printed format of the Bidding Documents provided that the bidders shall pay the applicable Bidding Documents Fee at least the day before the deadline for submission of their bids.
7. The DBP will hold a Pre-Bid Conference **on November 24, 2021, 2:00 PM** at **DBP Bldg. Osmena Blvd., P. del Rosario St., Cebu City**, which shall be open to prospective bidders. The following are the schedule of activities:

9. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
10. Bid opening shall be on **December 6, 2021, 2:00 PM** at the given address above. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The DBP reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
