
IV. Condition of the Contract:

- 3. Delivery period: The Supplier shall deliver the items within thirty (30) calendar days after receipt of Notice to Proceed (NTP)/ PO.
- 4. Point of Delivery: 2nd Floor DBP Building, Panganiban Dr., Naga City.

V. Payment:

- Payment shall be processed after completion of delivery subject to complete documents for payment (i.e. Billing Statement/ Statement of Account, Certificate of Completion/ Acceptance)
- 2. For every day of delay, 1/10 of 1% of the price of undelivered quantity shall be deducted from the payment, in case the Supplier fails to deliver the items on time.
- 3. Interested Supplier/s must submit the following:

 - c. Valid/Current Mayor's/ Business Permit
