2. **Please refer to the Section III. Bid Data Sheet (BDS) for the detailed procedure and options for the payment of bidding documents, submission and opening of bids. As indicated in the Invitation to Bid, bidders must secure the required payment for the bidding documents on or before the deadline of the submission and receipt of bids. Bidders are encouraged to attend the bid opening through Zoom Meeting App.**

3. **Replies to queries of the bidders:**

QUERY/CONCERN	CLARIFICATION
Are bidders required to submit samples during bid opening?	Yes. Per Checklist of Requirements, bidders shall submit, in a separate package, at least one (1) sample of t-shirt which must be compliant with all the required specifications.

QUERY/CONCERN	CLARIFICATION
Will the fabric be tested?	Yes. Eight (8) prototype/sample t-shirts shall be submitted by the bidder declared as the Lowest Calculated Bid (LCB) for the post-qualification and from there, three (3) samples will be submitted to the Philippine Textile Research Institute – Department of Science and Technology (PTRI-DOST) for testing.
When will be the deadline of payment for the bid docs?	Payment for the Bidding Documents fee can be made until before the deadline of submission of bids, but we recommend bidders <u>to pay at least one day before.</u>
When can we view the actual sample of polo shirt?	The fabric swatch is available to inspect/acquire through the BAC Secretariat at 6/F DBP Head Office, Mondays to Fridays, from 08:00 AM to 4:30 PM.
Once we view the actual sample where we can get the high res copy or ai file of the logo?	The high-resolution files of the logo will be provided to bidders through email upon request.
Is there a required color of envelope?	No requirement for the color of the bid envelopes.
If we send the hard copy of our bid documents, do we still need to send a soft copy?	No. One manner of submission is sufficient. If you will submit your bids manually (in hard copies), no need to submit soft copies.

4. **The Eligibility, Technical, and Financial Proposals must be properly tabbed for easy reference and must be submitted in sequence/order per Checklist of Requirements.**
5. **The BAC shall no longer entertain any question/request for clarification after the issuance of this Bid Bulletin.**
6. Please be advised that bids submitted after the deadline shall only be marked for recording purposes, shall not be included in the opening of bids, and shall be returned to the bidder unopened.
