<p>Clarification on the Bidding Document Section 1.2 (screenshot below). For this clause, will you allow us KPMG PH, a Philippine company, which is headed by Filipino citizen but some of the team members are from different nationality? If we have team members with different nationality, is this a disqualification or just a demerit in points?</p> <p>1.2. When the types and fields of Consulting Services involve the practice of professions regulated by law, those who will actually perform the services shall be Filipino citizens and registered professionals authorized by the appropriate regulatory body to practice those professions and allied professions specified in the <u>EDS</u>.</p>	<p>This is not a disqualification/demerit, provided the Solution Provider is at least 60% Filipino-owned company. Particularly in the case of Joint Venture arrangements where foreign vendor may be a partner to the extent of 40% equity, foreign individuals may form part of the Vendor's project team provided their profession is not regulated by the appropriate regulatory body in the Philippines and provided further that the below provisions of the RIRR of RA 9184 are complied with:</p> <p><u>Section 24.3.3. In order to manifest trust and confidence in and promote the development of Filipino consultancy, foreign consultants may be hired in the event Filipino consultants do not have the sufficient expertise and capability to render the services required under the project, as determined by the HoPE subject to the submission of the documents in accordance with Section 37.1.4(a)(iv).</u></p> <p><u>Section 37.1.4(a)(iv). In the case of Consulting Services, the SEC Certificate of Registration of the foreign consulting firm, and/or the authorization or license issued by the appropriate GoP professional regulatory body of the foreign professionals engaging in the practice of regulated professions and allied professions, where applicable.</u></p>
