**INVESTMENT OBJECTIVE AND STRATEGY**

The fund is a money market fund that aims to generate a steady flow of income with emphasis on capital preservation through investments in Special Deposit Account or other allowable deposit products of the BSP and deposit products of the Trustee or of its accredited banks with duration of not more than one (1) year. The fund intends to cater to the needs of individuals with conservative risk appetite and short-term investment horizon. It also aims to achieve returns higher than regular savings deposit.

**CLIENT SUITABILITY**

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

**Unlad Panimula Class III Money Market Fund** is suitable only for investors who:

- Are Individuals

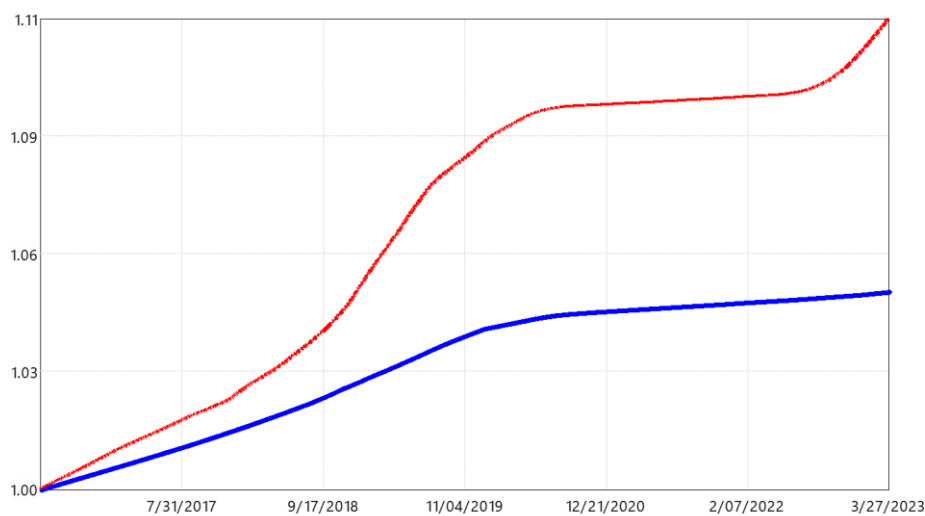

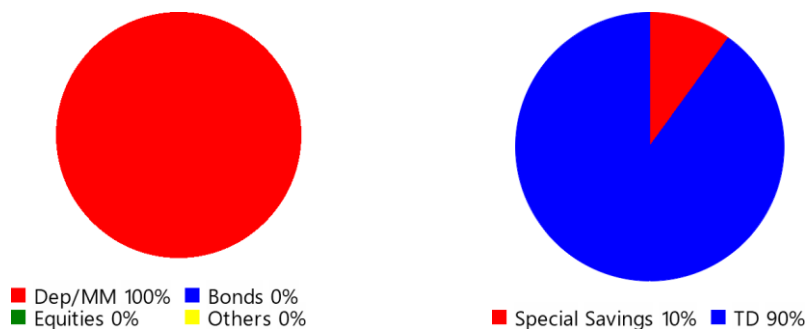
### NAVPu Graph

### RELATED PARTY TRANSACTIONS

As of 31 March 2023, the Fund has deposits with Development Bank of the Philippines (DBP) amounting to P201,040.26. Deposits with DBP, if any, shall be in accordance with the accreditation process approved by the Trust Committee. Likewise, all related party transactions are conducted on an arm's length basis.

### OUTLOOK AND STRATEGY

March inflation rate slowed down to 7.6%, lower than the 8.6% recorded in February 2023 but higher than 4.0% in March 2022. Lower inflation rate was mainly due to decrease in the prices of food, non-alcoholic beverages followed by transport and utilities. The average inflation rate for January to March 2023 posted at 8.3%, versus the 3.33% recorded for the same period last year.

As of March 2023, the yields for the 3-month, 6-month, and one-year T-bills averaged at 4.403%, 5.093%, and 5.503%, respectively, which are higher than the previous quarter. Meanwhile, private bank 30 days regular deposit rates averaged at 0.363%.

Returns on time deposits and special savings deposits remain higher than regular savings deposit, which is beneficial to the investment strategy of the fund. The fund will continue to invest primarily in short term placements within a 30 to 90-day range.

\*Starting January 1, 2020, the average 30-day time/special savings rate of the top 3 private universal banks, Land Bank of the Philippines and Development Bank of the Philippines replaces the Bloomberg Philippines 30-day Special Savings Rate General Average as benchmark.
