Warranty Security shall be in a form of a special bank guarantee or a letter confirmation for the retention money in the amount equivalent to 5% of the total contract price. The said amount shall be required for the entire Term, which may be effective initially for one (1) year, with the option to renew or extend the existing warranty. The retention money will be released after the lapse of the three (3) year warranty period under Section V of the Technical Specification. Provided, however, that the equipment delivered is free from patent and latent defects and all the conditions imposed under the contract have been fully met.
