- Please enclose the requested quotation in a sealed envelope and submit the same, on this address: Dr#1 LGU Public Market, Zone III Pob., Sta. Cruz, Davao del Sur or send via e-mail stacruzdavao@dbp.ph on or before **August 28, 2024**.
- The supplier shall ensure that the products delivered are in accordance with the specifications required by DBP. DBP has the right to reject items not according to the required specifications / model.
- DBP may terminate / cancel the PO when the Supplier/ Contractor fails to deliver, perform and comply with its obligation as required for in the contract.
- Delivery Period: The Contractor shall complete the delivery and construction within fourteen (14) calendar days after receipt of Notice to Proceed (NTP).
- Point of Delivery: Dr#1 LGU Public Market, Zone III Pob., Sta. Cruz, Davao del Sur
- DBP reserves the right to reject any and all quotations, to waive any defect in them and to award to the bidder whose price quotation is deemed most advantageous to the Bank.

PAYMENT:

- Payment shall be processed after completion of delivery subject to complete documents for payment (e.g. Billing Statement / Statement of Account, Certification of Completion / Acceptance). Issuance of manager's check will be the mode of payment and payment processing will be a maximum of 30 days or as indicated in the Purchase Order.
- For every day delay, 1/10 of 1% of the price of undelivered quantity shall be deducted from the payment, in case the Supplier fails to deliver the items on time.
