

#### III. CONDITIONS OF THE CONTRACT:

- The Supplier shall ensure that the items are in accordance with the specifications required by DBP.
- 2.DBP has the right to reject if items were found to be defective and not in accordance with the required specifications.
- 3. The DBP may terminate/cancel the Purchase Order (PO) when the Supplier fails to deliver, perform and comply with its obligation.
- 4. Delivery Period: The supplier shall deliver the items within 5 calendar days after receipt of Notice to Proceed (NTP).
- 5. Delivery Location: Receiving Section, Inventory Management Unit, Basement, DBP Bldg. Gil Puyat Avenue corner Makati Avenue, Makati City

The delivered items shall be received by the Receiving Section, Inventory Management Unit, PIMD in coordination with the Health and Wellness Unit (HWU) personnel – Mr. Lewelyn Alberto at local 2548 or Mr. Jun Tirado at local 3517.

### IV Payment:

- 1. Payment shall be processed after completion of delivery and subject to complete documents for payment (i.e. Billing Statement/Statement of Account, as applicable).
- 2. For every day of delay 1/10 of 1% (.001) of the price undelivered quantity shall be deducted from the payment, in case the Supplier fails to deliver the items on time. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of PO, the DBP may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it.
