The TWG cannot, at this point, ascertain the declared value of the items that will be shipped to Offsite Offices. Items to be shipped depend on the projects of various Business Units (BUs) and as enumerated in the Terms of Reference (TOR).









Did you accept or consider in providing proof of delivery (POD) that are generated in the system / portal of the service provider?	Historically, the highest declared value of the item that was shipped amounted to around PhP50,000.00 to PhP60,000.00 for one (1) unit of Personal Computer, while the lowest were valued at PhP145.00 for one (1) booklet Personal Check. No. the TWG will not consider accepting system/portal generated reports in place of physical PODs.
	The system-generated report lacks confirmation that the items have been received by the intended Offsite Offices of the Bank. This could jeopardize compliance with audit and regulatory requirements, as proof of receipt is essential for maintaining accountability.
