  - D. The selection of the lowest calculated proposal shall be based on the lowest calculated price provided compliant with the requirements.
- VII. Other Terms and Conditions:
  - A. No downpayment. Payment shall be processed after dismantling of Christmas décor and submission of complete documents for payment by the supplier (i.e. Billing Statement/Statement of Account, if applicable).
  - B. Penalty: For every day of delay of installation, 1/10 of 1% (0.001) of the price shall be deducted from the payment, in case the supplier fails to install the items on time. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the PO, the DBP may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it.
