1. The Philippine Government Procurement and Policy Board ("GPPB") issued the guidelines in the determination of Eligibility of Foreign Suppliers, Contractors, and Consultants to participate in Government Procurement Projects (the "Guidelines"). The Guidelines states that in the procurement of goods, a supplier, manufacturer and/or distributor who is a citizen, corporation or association of a country whose laws or regulations grant reciprocal rights or privileges allowing Filipino nationals to participate in public procurement in their country, is allowed to participate in government procurement projects. The Guidelines further provides that procuring entities shall confirm reciprocity from the list of countries maintained by the Department of Foreign Affairs ("DFA") and as shown in the GPPB website. However, to the best of our knowledge, as on date, there is no such list of countries maintained by DFA. Per its website, the GPPB is presently coordinating with the DFA in creating the list of countries with which Philippines enjoy reciprocal rights on matters of eligibility of its nationals in public procurement abroad. In light of the fact that GPPB is coordinating with the DFA to create the list of countries and that the DFA has not published the list of countries with reciprocal rights, none of the Bidder, who is not a Filipino citizen or organisation, will be able to comply with the said requirement. Hence, in our experience from the previous RFPs of Banks, while Banks have included the aforementioned condition, it was very well understood by the Banks that complying with the condition on reciprocal rights is not tenable in absence of the list of countries providing reciprocal rights published by DFA, and accordingly, the Banks have permitted the Bidders who are not Filipino citizens or organisations to

The prospective bidder may potentially qualify as an eligible foreign bidder either on the basis of reciprocity, by providing the required certification, or on the basis of non-availability of the goods from local suppliers. The determination of prospective bidder eligibility, as with any bidder, will be subject to evaluation by the Bids and Awards Committee (BAC) in accordance with the 2024 RIRR.

- 2. The Bank should also consider that NCR Atleos is an OEM and to the best of our knowledge, there are no local Filipino suppliers, who are manufacturers and who can provide direct services / support for the goods supplied locally through its infrastructure and skilled resources in Philippines. NCR Philippines will be obliged to provide an undertaking from NCR Atleos Corporation stating that NCR Philippines is authorized to distribute its machines and provide support / services needed to maintain the machines in good operating condition. Thus, complying with the eligibility criteria for a foreign supplier under the Guidelines when the goods sought to be procured are not available from local suppliers, who are not manufacturers.
- 3. Further, the Bank may note that Netherlands is a member of the EU.
