A. OBJECTIVE

- 4. Omnibus Sworn Statement (for winning supplier); and
- 5. Secretary's Certificate (for winning supplier under partnership/corporation).

C. APPROVED BUDGET FOR THE CONTRACT

D. SCOPE OF WORKS


- 1. Physical inventory, verifications and inspections of the mortgaged vessels shall be conducted; and
- 2. Appraisal Reports shall include the following:
 - a. Description/specifications of the units/vessels;
 - b. Serial/Body Numbers of engine room machinery, equipment, accessories and others;
 - c. Certificates of Ownership and Philippine Registry at the MARINA, Central Visayas, Cebu, and secure certified true copies of said documents (to be attached in the report):
 - d. Status/condition of the vessels;
 - e. Replacement Costs, New (RCNs);
 - f. Economic Life (EL) and Estimated Remaining Economic Life (EREL) of the vessels; and
 - g. Specific ports/locations where the units/vessels are inspected.

III. OTHER TERMS AND CONDITIONS

- A. Photographs of all assets/vessels shall be provided and properly labelled;
- B. If for any reason whatsoever, actual appraisal/valuation of an assets/vessels described in **Item I** was not made, appraisal fees shall be correspondingly decreased due to the incomplete appraisal work;
- C. Description of assets/vessels being appraised should follow the herein reflected descriptions. Any discrepancies observed as per actual inspection should be duly noted in the report:
- D. The Appraisal Report (AR) shall be submitted within 25 calendar days from the date of acceptance of the Notice to Proceed (NTP), otherwise, the corresponding penalty charges shall be charged accordingly. Should there be correction/s found necessary on the report during the Property Appraisal and Credit Investigation Department's (PACID's) evaluation, corrections thereof shall be done immediately, and the corrected report shall be submitted within three (3) working days from the date of advice to pick-up report for correction, otherwise, penalties shall likewise be imposed. Penalty is equivalent to one tenth of 1% of the contract amount for each day of delay:
- E. AR shall be subject to final review and evaluation by PACID to determine its completeness and conformity to the required information per above SOS;
- F. Payment of the appraisal service fee shall be made upon full completion of the engaged services to be facilitated by the Procurement and Inventory Management Department (PIMD) in coordination with RMD and upon clearance that the TOR has been fully complied with and acceptance of the AR by PACID;


