WHEREAS, Section 53.1.4 of the IRR of RA 12009 stated that, "The BAC shall recommend the short-list of consultants to the HoPE for consideration and approval. The entire process of eligibility checking, and short-listing shall not exceed twenty (20) calendar days.

NOW, THEREFORE, in consideration of the foregoing, upon careful evaluation of the eligibility requirements submitted by the bidder conducted by the members of the TWG for this procurement project, WE, the members of the Bids and Awards Committee, resolve as it is hereby RESOLVED:

- a.
