### CONTRACT AGREEMENT

WHEREAS, the Procuring Entity invited Bids for certain goods and ancillary services, viz., for the procurement of five (5) cash transport security services with armored car and fully secured armored security driver and two (2) security guards/escorts for each armored car for the use of the Procuring Entity's branches in Western Visayas (Cluster 7) for a period of two (2) years ("Services").

WHEREAS, after the conduct of public bidding, the Supplier was declared as the Single Calculated and Responsive Bidder and whose Bid was evaluated to be the most advantageous to the government thus, the Procuring Entity has accepted the Bid by the Supplier for the supply of those goods and services in the sum of PESOS: TWENTY-THREE MILLION EIGHT HUNDRED SEVEN THOUSAND FORTY-SEVEN & 68/100 (Php 23,807,047.68) for the two (2) years contract (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents, as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, shall be deemed to form, and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
  - (i) Schedule of Requirements;
  - (ii) Technical Specifications;
  - (iii) General and Special Conditions of Contract; and
  - (iv) Supplemental or Bid Bulletins, if any.
  - ii. Supplier's Bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted:
    - Bid form, including all documents/statements contained in the Supplier's bidding envelopes, as annexes, and all other documents submitted (e.g. Supplier's response to request for clarifications on the

bid), including corrections to the bid, if any, resulting from the Entity's bid valuation;

- iii. Performance Security;
- iv. Notice of Award of Contract and the Supplier's conforme thereto;
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity in the PBDs. Supplier agrees that additional contract documents or information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.
- In consideration of the sum of PESOS: TWENTY-THREE MILLLION EIGHT HUNDRED SEVEN THOUSAND FORTY-SEVEN & 68/100 (Php 23,807,047.68) or such other sums as may be ascertained, The Joint Venture of Fortress Armoured Transport, Inc. and Ascott Security and Investigation Agency, Inc. agrees to provide five (5) cash transport security services with armored car and fully secured armored security driver and security guards/escorts for two (2) years in accordance with its Bid.
- The **DEVELOPMENT BANK OF THE PHILIPPINES** agrees to pay the above-4. mentioned sum in accordance with the terms of the Bidding.
