

# Deposit Account for Financial Inclusion

Philippine Peso savings account with ATM

Required initial deposit : PhP100.00  
Required minimum ADB : None  
Required ADB to earn interest : PhP500.00

## Who are eligible to open this account:

- Individuals with regular and established small-value fund source (i.e. savings, stipend, allotment)
- Students, contract or seasonal workers, farmers, fisherfolk, OFWs, domestic workers/*kasambahay*, senior citizens, indigenous peoples, PWDs, micro-entrepreneurs, homemakers
- Individuals whose access to financial service providers is currently limited to pawnshops, remittance agents, money changers/foreign exchange dealers, non-stock savings and loan associations (NSSLAs), cooperatives, lending companies, financial companies, among others
- Individuals who reside in regions with low banking penetration, i.e. the Autonomous Region in Muslim Mindanao (ARMM); Cordillera Administrative Region; Eastern Visayas; Zamboanga Peninsula; Occidental Mindoro, Oriental Mindoro, Marinduque, Romblon, and Palawan

## Requirement:

At least one (1) original and unexpired identification document acceptable to DBP

Opening of this account shall follow BSP procedures under the Anti-Money Laundering Act (AMLA).
