AGREEMENT

THIS AGREEMENT (the "Agreement") made the _____ day of _____ 2025 between **DEVELOPMENT BANK OF THE PHILIPPINES**, a government financial institution duly created and existing under the provisions of Executive Order No. 81, the 1986 Revised Charter of DBP, as amended by Republic Act No. 8523 dated 14 February 1998, with principal office at DBP Makati Head Office, Sen. Gil Puyat Avenue Corner Makati Avenue, Makati City, Philippines, herein represented by its President and Chief Executive Officer, Michael O. de Jesus, (hereinafter called "DBP") of the one part, and **SYSTEMS AND SOFTWARE CONSULTING GROUP, INC.**, a corporation duly organized and existing by virtue of the laws of the Republic of the Philippines, with principal office address at Unit 214-218 Buma Building, 1012 Metropolitan Avenue, San Antonio Village, Makati City, Philippine 1203, herein represented by its Assistant Vice President, Christine Q. Mamaril, duly authorized for this purpose as shown in the attached Secretary's Certificate for Board Resolution [attached as Annex "F" hereof] (hereinafter called "the Supplier") of the other part:

WHEREAS, DBP invited Bids for certain goods and ancillary services, viz., the Supply, Delivery, Installation, Configuration, Migration, Testing and Commissioning of the Up-To-Date Anti-Money Laundering (AML) Electronic System and Automated Real-Time Fraud Monitoring and Detection System (FMS). After the conduct of public bidding, the Supplier was declared as the Lowest Calculated and Responsive Bidder and whose Bid was evaluated to be the most advantageous to the government and thus, DBP has accepted the Bid by the Supplier for the supply of those goods and services in the sum of PESOS: SEVENTY-EIGHT MILLION SEVEN HUNDRED EIGHTY-EIGHT THOUSAND EIGHT HUNDRED EIGHTY-EIGHT AND 88/100 (PHP78,788,888.88) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- This Agreement shall take effect upon signing hereby of the Parties, and the Supplier shall commence performance of its obligations upon issuance by DBP of a Notice to Proceed. This Agreement shall continue to be in full force and effect from the date of signing of this Agreement until completion of herein services or until terminated in accordance with the provisions on *Termination* under the RA No. 9184 and its 2016 Revised Implementing Rules and Regulations or at any time upon the instruction of the Bangko Sentral ng Pilipinas (BSP).
- The Contract Price shall be paid by DBP in accordance with the bidding documents and the terms and conditions stated herein.
- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 4. The following documents, as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - (ii) Philippine Bidding Documents (PBDs);
 - (i) Schedule of Requirements;
 - (ii) Terms of Reference or Technical Specifications (Annex A);
 - (iii) General and Special Conditions of Contract; and
 - (iv) Supplemental or Bid Bulletins, if any.
 - (iii) Supplier's Bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted, Bid form, including all documents/stated contained in the Supplier's bidding

envelopes, as annexes, and all other documents submitted (e.g. Supplier's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from DBP's bid valuation;

- (iv) Performance Security (Annex B);
- (v) Notice of Award of Contract and the Supplier's conforme thereto (Annex C);
- (vi) Performance Evaluation of 3rd Party Contracts/Agreements (Annex D);
- (vii) Data Privacy Consent Form (Annex E);
- (viii) Supplier's Secretary's Certificate for Board Resolution (Annex F); and
- (ix) Other contract documents that may be required by existing laws and/or DBP in the PBDs. Supplier agrees that additional contract documents or information prescribed by the Government Procurement Policy Board (GPPB) that are subsequently required for submission after the Agreement's execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Agreement.

The Parties shall endeavor to harmonize the provisions of this Agreement and the Annexes so that each shall be effective. In the event of any inconsistency between the terms of this Agreement and the Annexes, the terms of the Annexes shall prevail to the extent necessary to resolve such inconsistency. In the event of any conflict between the provisions of this Agreement including the annexes and the Terms of Reference or Technical Specifications, as the case may be, the terms of the Terms of Reference/Technical Specifications shall prevail.

- 5. In consideration for the sum of Pesos: Seventy-Eight Million Seven Hundred Eighty-Eight Thousand Eight Hundred Eighty-Eight and 88/100 (PhP78,788,888.88) or such other sums as may be ascertained, the Supplier agrees to supply, deliver, install, configure, migrate, test and commission the up-to-date Anti-Money Laundering (AML) Electronic System and Automated Real-Time Fraud Monitoring and Detection System (FMS) in accordance with its Bid and the terms and conditions of this Agreement.
- 6. DBP agrees to pay the above-mentioned sum in accordance with the terms of the Bidding and of this Agreement.
