Important Guidelines

- i) The guests shall advise the resort of the finalized number of guests 1 week before the date of the event. Failure to do so might lead to a shortage of food and rooms for which the resort will no longer be responsible.
- ii) All payments are non-refundable. The resort assumes that all bookings and reservations made by the client are final unless stated otherwise.
- iii) In cases of miscounting the number of guests per group, the resort will follow what was stated by the client in his/her reservation. The client will then be responsible for paying the amount that was initially determined by the resort in the agreement. The resort assumes that the number of guests given by the client is accurate and final unless stated otherwise (see guideline i.).

iv) CANCELLATION POLICY

- a. Clients who are able to notify the resort FIFTEEN (15) DAYS before their check-in date shall be charged FIFTY PERCENT (50%) of the total guaranteed package.
- b. Clients who are able to notify the resort SEVEN (7) DAYS before their check-in date shall be charged the FULL AMOUNT of the total guaranteed package.

v) CHANGE OF DATE

Clients shall be allowed to change the date of the event provided that there is appropriate advice to the resort at the very least FIFTEEN (15) DAYS before the event. Consequently, the group as a result of this acknowledges that should there be any price increase/movement in the following items/services; (1) room rates; (2) function room space & rental rates; (3) menu price/s of food and beverage; and reprinting of collateral materials; the engager fully recognizes the said price increase/movement (if any) and shall therefore agree to the said change/s.

vi) EVENT RESERVATION

A FIFTY PERCENT (50%) downpayment is required to make a reservation before the event. The remaining balance shall be settled upon check-in.
