

II. Technical Specifications:

Supply, delivery, installation and testing & commissioning of 200AT, 3-Phase Automatic Transfer Switch (ATS) as per technical specification (see Annex A).

III. Conditions of the Contract:

- The Supplier must conduct inspection and verification of the actual area of construction/ installation.
- All necessary pipes, wires/cables, supports and accessories shall be provided by the contractor to complete all requirements to operate the 200AT, 3-Phase Automatic Transfer Switch (ATS) along with existing generator set.
- The Supplier shall ensure the compatibility of the 200AT, 3-Phase Automatic Transfer Switch (ATS) to existing generator set.
- The Supplier to make sure no damages will occur during the removal/ dismantling & installation of Automatic Transfer Switch (ATS) and its system components. Any resulting damage will be charged accordingly.
- The Supplier to provide necessary temporary protection on the work areas affected by the activities.
- 6. The Supplier must submit sample/s of materials/technical specification/shop drawing related to the project for approval by DBP before fabrication/installation. DBP has the right to reject delivery if item/s delivered were found to be defective and not according to the required specifications/model.
- DBP may terminate/cancel the Purchase Order (PO) when the Supplier fails to deliver, perform and comply with its obligation.

 Delivery and Installation Period: The Supplier shall complete the project within thirty (30) calendar days after receipt of Notice to Proceed (NTP).

- 9. Warranty: One (1) year warranty upon acceptance of items by DBP.
- 10. Retention: The obligation of the warranty shall be covered by a retention money equivalent to 3% of the total contract price. The retention money shall only be released three (3) months after completion of delivery while the remaining warranty period shall be covered by a Warranty Certificate. Provided, however, that the items are free from patent and latent defects and all the conditions imposed under the contract have been fully met.
- 11. Performance Security: To guarantee the faithful performance of obligations, the winning bidder is required to post within ten (10) calendar days from receipt of Notice of Award, a performance security (to expire upon completion of the project) in any of the following forms and percentages:

Upon receipt of such notice, the Supplier shall, within the period of ten (10) calendar days and with all reasonable speed, repair or replace the defective item or parts thereof, without cost to the Bank.

- For every day of delay, 1/10 of 1% (0.001) of the price of undelivered item/s shall be deducted from the payment, in case the Supplier fails to deliver the items on time. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of PO/NTP, DBP may rescind or terminate the contract, without prejudice to other courses of action and remedies open to it.
- 3. In case the total sum of liquidated damages reaches ten percent (10%) of the total contract price, DBP may terminate the contract or allow the contractor to continue the works without prejudice to the continued imposition of liquidated damages until the works have been completed. This does not, however, preclude DBP in resorting to Termination of Contract under Annex I of the 2016 revised IRR of RA No. 9184.
