

## IV. Warranty and Retention:

- At least one (1) year warranty on parts and service upon completion of all works.
- The Supplier warrants that the Goods supplied are new, unused, and free from defects.
- 3. The obligation of the warranty shall be covered by a retention money equivalent to 3% of the total contract price. The retention money shall only be released three (3) months after completion of delivery while the remaining warranty period shall be covered by a Warranty Certificate. Provided, however, that the items are free from patent and latent defects and all the conditions imposed under the contract have been fully met.
- 4. DBP shall promptly notify the Supplier in writing of any claims arising under the warranty (Notice of Defects). Upon receipt of such notice, the Supplier shall, within the period of ten (10) calendar days and with all reasonable speed, repair or replace the defective item or parts thereof, without cost to the Bank.

#### V. Payment:

- 1. Payment shall be processed after completion of delivery subject to submission of the following complete documents for payment:
  - Letter of Request for Payment, or Billing Statement
  - Statement of Work Accomplishment
  - Supplier's Affidavit
  - Project Pictures
  - Certificate of Completion/Acceptance
- Once the contract duration expires, including any time extension duly granted, and the Supplier refuses or fails to satisfactorily complete the work, DBP shall impose upon the Supplier default liquidated damages. Liquidated damage is an amount equal to at least one tenth (1/10) of one (1) percent of the cost of the unperformed portion of the works for every day of delay.

3. In case the total sum of liquidated damages reaches ten percent (10%) of the total contract price, DBP may terminate the contract or allow the contractor to continue the works without prejudice to the continued imposition of liquidated damages until the works have been completed. This does not, however, preclude DBP in resorting to Termination of Contract under Annex I of the 2016 revised IRR of RA No. 9184.
