Description

INVITATION TO BID FOR SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING FIVE (5) UNITS POWER GENERATOR SET (INCLUDING PERMIT TO OPERATE (PTO) APPLICATION PLANS, PREP & SIGNING BY PME)

- 1) The Development Bank of the Philippines through the Corporate Budget for 2025 intends to apply the sum of Five Million Seven Hundred Thousand Pesos (P 5,700,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply, Delivery, Installation, Testing and Commissioning of Five (5) Units Power Generator Set (Including Permit to Operate (PTO) Application Plans, Prep & Signing by PME) [PB No. 2025-001]. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
- 2) The Development Bank of the Philippines now invites bids for the above Procurement Project. Delivery of the Goods is required by Ninety (90) calendar days upon receipt of Purchase Order or Notice to Proceed. Bidders should have 5 years from the date of submission and receipt of bids, a contract similar to the Project. - 3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of

a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 7. Bids must be duly received by the BAC Secretariat through manual submission only at the DBP BBG-SL Office of the Head, Merchan Street, Barangay IX, Lucena City, Quezon Province, Philippines on or before September 8, 2025, 11:00 AM (Philippine Standard Time). Late bids shall not be accepted.
- 8. All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
