AGREEMENT

THIS AGREEMENT made the _____ day of _____ 2025 between *DEVELOPMENT BANK OF THE PHILIPPINES*, a government financial institution duly created and existing under the provisions of Executive Order No. 81, the 1986 Revised Charter of DBP, as amended by Republic Act No. 8523 dated 14 February 1998, with principal office at DBP Building, Sen. Gil Puyat corner Makati Avenue, Makati City, Philippines, herein represented by its President and Chief Executive Officer, *Michael O. De Jesus* (hereinafter called "the Entity") of the one part and *TRENDS AND TECHNOLOGIES*, *INC.*, a corporation duly organized and existing under Philippine laws, with principal office address at 6th Floor, Trafalgar Plaza 105 H.V dela Costa St. Salcedo Village, Makati City, herein represented by its Account Manager, *Patricia Nicole C. Domingo*, duly authorized for this purpose as shown in the attached Secretary's Certificate for Board Resolution (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly supply, delivery, installation, commissioning and maintenance of Internet Protocol (IP) PABX System and Ancillary Solution and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of PESOS: FIFTY-NINE MILLLION EIGHT HUNDRED THOUSAND (Php 59,800,000.00), (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents, as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - (a) Philippine Bidding Documents (PBDs);
 - (i) Schedule of Requirements;
 - (ii) Technical Specifications (Annex A);
 - (iii) General and Special Conditions of Contract; and
 - (iv) Supplemental or Bid Bulletins, if any.
 - (b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (c) Performance Security (Annex B);
- (d) Notice of Award of Contract (Annex C) and the Bidder's conforme thereto; and
- (e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional

contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of PESOS: FIFTY-NINE MILLLION EIGHT HUNDRED THOUSAND (Php 59,800,000.00) or such other sums as may be ascertained, TRENDS AND TECHNOLOGIES, INC. agrees to supply, deliver, install, commission and maintain IP PABX System and Ancillary Solution in accordance with its Bid.
- 4. The **DEVELOPMENT BANK OF THE PHILIPPINES** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
