ONE (1) LOT SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF 2KVA, 6KVA, AND 10KVA UNINTERRUPTIBLE POWER SUPPLY (UPS) FOR VARIOUS BBG-SOUTHERN MINDANAO BRANCHES

1) The Development Bank of the Philippines, through the Corporate Budget for 2025 intends to apply the sum of Four Million Four Hundred Ten Thousand Pesos (P4,410,000.00), inclusive of all applicable taxes, being the Approved Budget for the Contract (ABC) to payments under the contract for the One (1) Lot Supply, Delivery, Installation, Testing and Commissioning of 2KVA, 6KVA, and 10KVA Uninterruptible Power Supply (UPS) For Various BBG-SM Branches, with details as attached.

2) The Development Bank of the Philippines now invites bids for the above-cited procurement project. Bids received more than the ABC shall be automatically rejected at bid opening. Delivery of the Goods and Completion of Works is required within Sixty (60) calendar days from receipt of Notice to Proceed (NTP). Bidders should have completed contracts similar to the Project at least five (5) years from the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as

specified in the IRR of RA No. 12009. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No.5183.

4) Interested Bidders may obtain further information from the Development Bank of the Philippines and inspect the Bidding Documents at the address given below on Mondays to Fridays from 9:00 AM to 3:00 PM.

5) A complete set of Bidding Documents may be acquired by interested Bidders on September 18, 2025 from the address given below upon payment of the applicable non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees via physical presentation of original DBP Official Receipt or sending of scanned copy of the DBP Official Receipt via email (sm-bbg@dbp.ph).It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) (www.philgeps.gov.ph) and DBP Website (www.dbp.ph), provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6) The Development Bank of the Philippines will hold a Pre-Bid Conference on September 26, 2025 at 10:00AM at BBG-SM Mezzanine Floor, DBP General Santos Building, Roxas Avenue, General Santos City and/or through video conferencing via Zoom or Microsoft Teams, which shall be open to prospective Bidders.

7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through manual submission at the office address indicated below, on or before October 08, 2025 on or before 9:00AM. Late bids shall not be accepted.

8) All Bids must be accompanied by Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

9) Bid opening shall be on October 08, 2025 at 9:30AM at BBG-SM Mezzanine Floor, DBP General Santos Building, Roxas Avenue, General Santos City and/or through video conferencing via Zoom or Microsoft Teams. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.

10) The Pre-Bid Conference shall be open to all interested parties. Bidders are advised to send their authorized technical and/or administrative representatives who will prepare the bid documents to ensure completeness and compliance of bids. Bids submitted after the deadline shall only be marked for purposes of recording the time of submission to the DBP BAC Secretariat but shall not be accepted, thus, they shall be returned to the bidder unopened and intact. Bidders are advised to regularly check the DBP and PhilGEPS websites for bid bulletins/ announcements regarding the project.
