## **VENUES RULES AND REGULATIONS**

Extensions: Daytour is from 8 am to 5 pm. Overnight is from 8 am to 7 am. Night program is until 10pm only. Room use is 1pm to 8 am for overnight and 8 am to 5 pm for day use. Functions that will extend beyond this time, or beyond the time provided in the contract, unless expressly allowed by management, will be charged accordingly. Please check Add On Fees document for other applicable extension fees.

Rates: Due to the many factors that affect supplies, rates and fees of items/services may change without prior notice.

Charging and Use of Electric Outlets: Using of electrical outlets specially using extensions is not allowed unless expressly given permission by authorized Quest representative. In which case, standard fees and electrical corkages shall apply.

Cooking: Cooking inside the venue is prohibited unless otherwise expressly permitted by authorized representatives. In which case, standard fees shall apply.

Selling: Any form of selling by guests is strictly prohibited inside the venue. Venue may confiscate items and be returned upon checkout.

Tickets: Tickets purchased for any of the rides and facilities should be used during the booking period, otherwise, the same shall be forfeited. Tickets once purchased shall be non-refundable regardless of the circumstance or reason (sickness, health, etc).

Lights Out: To ensure safety, Quest will observe lights out at exactly 10pm. Activities beyond this time must be coordinated and approved by Quest.

Children: Safety of toddlers and children will be under full responsibility of parents/adults accompanying them.

## **TERMS AND CONDITIONS**

- 1. Upon signing this quotation, required 50% down payment must be paid and sent to our office within 3 working days from the date of signing. Otherwise, this proposal/agreement will be automatically considered null and void. Any tentatively reserved venue facilities can be offered to other clients.
- 2. For Send bill arrangements, official Purchase Order will be provided by client as confirmation of booking. Other documents and instructions for payment collection shall be provided by client.
- 3. Paid reservation fee is non-refundable.
- 4. Balance and other accrued charges is payable before check out through CASH only. Company and Personal checks will not be accepted for on site payments. In case of delayed payments or submission of required documents, collection of receipts or other documents that can otherwise be received before camp check out will be shouldered by client.
- 5. CANCELLATION. Should the reservation be cancelled for whatever reason, 50% reservation fee will be forfeited and will not be refunded.

Cancellation charges are as follows:

7 – 1 day/s before the event – 100% cancellation charge of remaining balance 15 - 8 days before the event – 50% cancellation charge of remaining balance 30 – 16 days before the event – 25% cancellation charge of remaining balance No Show – 100%

Cancellation fees are charged for any loss business that resulted by giving reservation to client.

Cancellation fees will be applied to reserved rooms and reserved facilities.

Same amount will be billed to clients with send bill arrangement.

- 6. CHANGE IN NUMBER. Change in guaranteed number of participants will be accommodated up to 10 working days before the event. After which, full payment for signed contract is payable as agreed upon.
- 7. GUARANTEED NUMBER. Amount paid for no-show guests are non-refundable and non-changeable to other service or products.
- 8. CHANGES. All requests for changes in menu/date/number of participants/activities has to be forwarded to the account executive via email. Such requests are not guaranteed until approved via email. Any changes will not be executed until new contract is signed by both client and Quest.

9. REBOOKING, For re-scheduling within 5 days before event date, rebooking penalty fee is 20% of contract amount.

In case of bad weather, client may opt to postpone the event until 24 hours before the event. Rebooking fee will be collected to cover perishable items already purchased for client's event. New schedule must be within 4 months of original event date. In such event, a new contract will be made to include new details of the event. In case of new rates, updated rates will be applied to new contract,

10. FORTUITOUS EVENTS. Any disturbance or discontinuance of this agreement due to causes beyond the control of the Camp shall confer no right or cause of actions against the CAMP, nor shall the terms and conditions of such agreement be deemed effective and/or continued thereby.

Both parties shall not be liable for failure to comply with this agreement due to force majeure including, but not limited to: labor disputes, natural disaster or other causes beyond the control of both parties.

- 11. INCIDENTAL AND ADDITIONAL CHARGES. Any incidental charges, additional charges, loss/damages to the venue has to be paid by the client before check out.
- 12. FOOD CHOICES: All food choices must be forwarded by email up to ten (10) days before the event. Otherwise, menu will be under chef's discretion.
- 13. Any loss, damage or injury that the Camp guests may suffer, attributable to acts or omission of the client and/or his/her guests during the contracted function, whether deliberate or through negligence, shall give rise to the latter's liabilities which the camp guests may recover under existing laws. The client and/or his/her guests shall keep the Camp free from any liability arising from their acts or omissions which caused loss, damage or injury.
- 14. The Camp shall not be liable for any damages or loss of merchandise left, during or after the period of stay.
- 15. Bringing of packed/cooked food and drinks are allowed. Alcoholic drinks are permitted with restriction and corkage fees.
- 16. The guest will not hold the Camp liable for any illness resulting from consumption of food taken from outside the camp.
- 17. Gambling and use of prohibited drugs are strictly prohibited. Smoking is limited to designated smoking areas only.
- 18. Pets are not allowed inside the Camp.
- 19. Littering, unauthorized picking of fruits, plants and/or flowers are not allowed.
- 20. Unauthorized posting of any markings, posters, collateral and other signage is not allowed.
- 21. To ensure safety for everyone inside the camp any firearms, knives or deadly weapons are to be surrendered to the in-house security for safekeeping.
- 22. Unauthorized attachments to the floors, walls, ceilings or columns of the Camp facilities by nails, screws, pins, tapes, double sided tapes, gun tucker or other means is not allowed. Any damage shall be chargeable to the guests.
- 23. Flammable and explosive materials are not allowed inside the Camp.
- 24. The Client understands that the program and facilities require moderate to high level of fitness, is physically testing and may pose great challenge brought about by the participants and/or nature with all its living and non-living elements. Any person with any medical condition or prohibition is advised to secure medical clearance. The Client accepts that there is a risk of injury when undertaking such activities and the Client will not hold the Camp in any way liable for injuries and/or accident that the participants may suffer in the course of the event. The Client waives all and any claims against the Camp in this respect. In any event requiring medical attention, the Camp will provide first aid kit, nurse assistance and/or, should the need arises, transportation to bring the Client to the nearest hospital.
- 25. While security guards are visible inside the Camp, the Camp is likewise not responsible for any loss of personal belongings or items.
- 26. LEFTOVER POLICY. For the health and safety of our clients, we do not allow leftover food to be packed for our clients. Should the client insist, food containers will be provided for a fee, if needed. In such case, the client agrees that he/she shall not hold Quest Adven from any liability in event of food spoilage.


