- I. APPROVED BUDGET FOR THE CONTRACT (ABC): TWO HUNDRED THIRTY-THREE THOUSAND FOUR HUNDRED FORTY-SEVEN PESOS AND 38/100 (P233,447.38), INCLUSIVE OF ALL TAXES
- **II. SCOPE OF WORKS AND TECHNICAL SPECIFICATIONS:**

The Contractor shall hold all obligations, duties and responsibilities necessary to the successful completion of the contract assigned to or be undertaken, including all labor, materials, equipment and services, other incidentals, i.e. bonds and insurance, contractor's all risk (CARI); and furnishing thereof in accordance with the drawings, specifications and all addenda prepared by DBP.

The contractor must supply or install items, materials, and products which are compliant with the certification requirements issued by the Bureau of Philippine Standards of Department of Trade and Industry (DTI-BPS).

2. SITE WORKS

- 4.1 CHB shall be normal weight and in conformance to ASTM C-90, Type 1 with plastering both sides, rebar diameter shall be 12mm (vertical bars) and 10mm (horizontal bars) and concrete filler mixture/ratio shall be class A (provide absorption and compressive test result for CHB and tensile strength test for rebars from DPWH accredited testing laboratory).
 - 4.1.1 100mm CHB (400 PSI compressive strength minimum)
 - Bundwall including 2-12mm horizontal bar and 10mm vertical bar at 400mm O.C. reinforcing bars
 - 4.1.2 25mm plastering
 - Bundwall

5. METAL WORKS - FABRICATION OF GENSET HOUSING

- 5.1 Framing post and beams
 6mm x 75mm x 75mm Bl tubular bar
 - 6mm x 50mm x 75mm Bl tubular bar Includes the following:
 - 10mm thk base plate
 - 12mm anchor bolts
- 5.2 Roof framing
 - 50mm x 75mm C purlins
- 5.3 Door frame and accessories
 - 4mm x 50mm x 50mm Bi tubular bar

- Barrel bolt
- Foot bolt
- 4-12mm cylindrical hinges per door

- 5.4 Roofing light gauge materials
 - 5.4.1 GI roofing GA 24 pre-painted rib type with double faced insulation
- 5.5 Louvers aluminum
 - 5.5.1 Louvers 2mm thk aluminum (analok finish)

Louver panels:

- Door louver panel 1 (1.30m H x 0.475m W) 6 units
- Door louver panel 2 (1.30m H x 0.460m W) 4 units
- 5.6 Extension of genset exhaust pipe
 - 75mm BI pipe and fittings and accessories

PAINTING WORKS

- 6.1 Painting of building exterior
 - 6.1.1 Semi-gloss acrylic latex pain
 - Affected exterior concrete walls at the rear of the Branch
- 6.2 Painting of genset housing and exhaust pipe extension
 - 6.2.1 Acrylic water based epoxy paint

- In case of discrepancies between the working drawings and Scope of Works/Technical Specifications, the Contractor shall coordinate, verify and confirm with DBP before proceeding with the works.

III. CONDITIONS OF THE CONTRACT:

- 1. The Contractor shall ensure that the items delivered are in accordance with the specifications required by DBP. DBP has the right to reject delivery if item/s delivered were found to be defective and not according to the required specifications.
- 2. The Contractor shall submit, construction schedule reflecting all activities needed to complete the project, their sequence and duration.

- 3. The Contractor must submit sample/s of materials and devices for approval by DBP before installation.
- 4. The Contractor shall designate or employ a full-time project coordinator that will supervise on-site works and activities.
- 5. DBP may terminate/cancel the Purchase Order (PO) / Notice to Proceed (NTP) when the Contractor fails to deliver, perform and comply with its obligation.
- 6. Project Period: The Contractor shall complete the project within forty-five (45) calendar days after receipt of Purchase Order (PO) / Notice to Proceed (NTP).
- 7. Warranty: One (1) year warranty upon completion of all works.

IV. PAYMENT:

A one-time full payment shall be processed after the completion of the project subject to submission of the following complete documents:

- Letter of Request for Payment
- Statement of Work Accomplishment'
- Contractor's Affidavit
- Project Pictures

V. LIQUIDATED DAMAGES:

- 1. Once the contractor fails to satisfactorily complete the works under the contract within the specified contract duration, inclusive of duly granted time extensions, if any, the contractor shall be liable for liquidated damages in an amount equal to at least one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion of the works for every day of delay.
- 2. In computing liquidated damages, the DBP shall determine the usability of the project.
 - A project or a portion thereof may be deemed usable when it starts to provide the desired benefits as certified by the targeted, End-User or Implementing Units and the DBP.
- To be entitled to liquidated damages, the DBP does not have to prove that it has incurred actual damages. The specified amount may be deducted from any funds currently due or that may become due to the contractor under the contract, in a manner deemed appropriate by DBP.
- 4. In case the total sum of liquidated damages reaches ten percent (10%) of the total contract price, the DBP may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances. This does not, however, preclude the DBP in resorting to Termination of Contract under Section 71.4 of the IRR of R.A. 12009.
