#### Notes:

- Distribution transformer's specification, rating and actual number shall be based on the final recommendation of Local Electric Cooperative.
- Distribution transformer shall be calibrated and tested by the service provider prior to installation.
- Supplier shall submit proof of test results or approval from the service provider through certification/ transmittal or tampered-proof seal.

#### III. CONDITIONS OF THE CONTRACT:

- The Supplier shall conduct ocular site inspection and verification of the actual construction/ installation area.
- All wires required (primary & secondary wires), mounting accessories shall be provided by the supplier to complete all requirements to operate the Single-Phase Distribution Transformer.
- The Supplier is responsible for providing and installing the feeder line, conduits, service entrance, and all other necessary accessories. This includes any chipping, demolition and trenching required for a proper installation.
- The Supplier shall submit all necessary documents and pay all applicable fees for permanent power application (including Bill deposit, care of DBP) until final connection.
- The Supplier shall provide necessary temporary protection for the work areas affected by the activities.
- The Supplier shall submit all documents via email to the Branch email address and cfmd@dbp.ph.
- 7. The Supplier must submit sample/s of materials/technical specifications and shop drawings related to the project for approval by DBP before fabrication/installation. DBP reserves the right to reject delivery if the item/s or are found to be defective or do not meet the required specifications or model.
- DBP may terminate/cancel the Purchase Order (PO) when the Supplier fails to deliver, perform and comply with its obligation.
- Delivery Period: The Supplier shall complete the project within Thirty (30) calendar days after receipt of Notice to Proceed (NTP).
- 10. Point of Delivery: Puerto Princesa National Road, Poblacion Narra IV-B Mimaropa
- 11. Warranty: One (1) year warranty upon acceptance of items by DBP.

# VI. LIQUIDATED DAMAGES:

Once the contractor fails to satisfactorily complete the works under the contract within the specified contract duration, inclusive of duly granted time extensions, if any, the contractor shall be liable for liquidated damages in an amount equal to at least one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion of the works for every day of delay.

In computing liquidated damages, the DBP shall determine the usability of the project. A project or a portion thereof may be deemed usable when it starts to provide the desired benefits as certified by the targeted End-User or Implementing Units and the DBP.

To be entitled to liquidated damages, the DBP does not have to prove that it has incurred actual damages. Such amount shall be deducted from any money due, or which may become due the contractor under the contract, collected from the retention money or other securities posted by the contractor, or a combination thereof, whichever is convenient to the DBP.

In case the total sum of liquidated damages reaches ten percent (10%) of the total contract price, the DBP may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances. This does not, however, preclude the DBP in resorting to Termination of Contract under Section 71.4 of the IRR of R.A. 12009.
