TERMS OF REFERENCE

I. APPROVED BUDGET FOR THE CONTRACT

The Approved Budget for the Contract (ABC) is One Million Five Hundred Six Thousand Six Hundred Eighty-Three Pesos and 08/100 (₱ 1,506,683.08) or equivalent to ₱ 37,667.077 per license, inclusive of VAT/applicable taxes and other changes.

II. SUBSCRIPTION COVERAGE

The one (1)-year GitHub Enterprise Plan and GitHub Copilot for Business Users shall commence upon issuance of the Notice to Proceed and subsequent activation of the license.

IV. DELIVERY/ACTIVATION PERIOD

The supplier shall load the license in DBP's Microsoft 365 account electronically within seven (7) working days upon receipt of Notice to Proceed (NTP).

V. WARRANTY

- 1. Warranty Period: One (1) month warranty upon activation of the license to DBP.
- 2. DBP shall promptly notify the Supplier in writing of any claims arising under this warranty (Notice of Defects). Upon receipt of such notice, the Supplier shall, within the period of five (5) calendar days and with all reasonable speed, replace the defective Goods, without additional cost to the Bank.

VI. OTHER REQUIREMENTS:

- The Supplier shall ensure that the licenses supplied are in accordance with the Terms
 of Reference as required by the DBP. DBP has the right to reject delivery if licenses
 provided are found to be defective and not in accordance with the Terms of
 Reference.
- 2. DBP may terminate /cancel the Purchase Order (PO) if the Supplier fails to deliver, perform, and comply with its obligation.
- 3. The Supplier shall, upon activation of the license, notify DBP via email at cvallo@dbp.ph or mlamoroso@dbp.ph, and thereafter provide DBP with proof of entitlement.
